o The revised policy clarifies that the Governing Body of St. Anne's Catholic High School for Girls is the admissions authority for St. Anne's Catholic High School for Girls, and co-ordinates with Enfield Local Authority for the administration of admissions applications.

- ➤ the timeframe for the determination of and representation about the admissions arrangements to be set so they are in line with section 1.46 of the DFE admissions code.
- > the oversubscription criteria to decouple Catholic Looked After or Previously Looked After children and Non- Catholic Looked After or Previously Looked After children
- > to update the definitions in the oversubscription criteria of Looked After child, parent, Eastern Christian Church, sibling and residential/home address to adopt the same definition as the Catholic Education Service.
